**ORDINANCE #563**

**AN ORDINANCE AMENDING ORDINANCE 415  
AN ORDINANCE AUTHORIZING THE OPERATION OF ALL-TERRAIN UTILITY  
VEHICLES ON THE VILLAGE OF GREENUP STREETS UNDER THE JURISDICTION  
OF VILLAGE OF GREENUP, CUMBERLAND COUNTY, ILLINOIS**

**WHEREAS**, the Village of Greenup, Illinois, previously enacted An Ordinance Authorizing the Operation of All-Terrain Utility Vehicles on the Village of Greenup Streets Under the Jurisdiction of the Village of Greenup, Cumberland County, Illinois (Ordinance No. 415);

**WHEREAS**, the Village of Greenup, Illinois, wishes to change the registration fee for golf carts as provided in Subsection C of said Ordinance; and

**WHEREAS**, the Village of Greenup, Illinois, wishes to amend Ordinance No. 415 with respect to the cost of a permit under said Ordinance.

**NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE BOARD OF TRUSTEES  
OF THE VILLAGE OF GREENUP, CUMBERLAND COUNTY, ILLINOIS:**

**Section 1:** The findings made in the prefatory portion of this Ordinance are hereby adopted.

**Section 2:** That the cost for a permit under Subsection C(l) is changed to reflect an amount of FORTY-FIVE DOLLARS (\$45.00).

**Section 3:** That in all other respects, said Ordinance remains in full force and effect.
