**AN ORDINANCE AMENDING THE PAYMENT OF CABLE TELEVISION
FRANCHISE FEES IN THE VILLAGE OF GREENUP, ILLINOIS**

WHEREAS, Mediacom Illinois, LLC operates a cable television system providing cable television services to households in the Village of Greenup, Illinois, authorized under an Authorization to Offer Cable or Video Services granted by the Illinois Commerce Commission on April 9, 2018 pursuant to 220 ILCS 5/21-401; and,

WHEREAS, 220 ILCS 5/21-401 permits the Village of Greenup, Illinois to collect service provider fees from a cable operator operating within the Village of Greenup, Illinois pursuant to state authorization; and,

WHEREAS, the Village of Greenup previously passed a substantially similar ordinance on May 7, 2018;

WHEREAS, 220 ILCS 5/21-801(c)(1) was amended in 2024 adjusting the service provider fee payable to municipalities from 3% to 5%; and

WHEREAS, the Village of Greenup, Illinois hereby adopts this Ordinance in order to amend the amount of service provider fees it is permitted to collect service from Mediacom Illinois, LLC pursuant to 220 ILCS 5/21-401.

**NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF
THE VILLAGE OF GREENUP, CUMBERLAND COUNTY, ILLINOIS, AS FOLLOWS:**

Section 1: Mediacom Illinois, LLC shall pay annual service provider fee to the Village of Greenup in an amount equal to 5% of annual gross revenues as defined in 220 ILCS 5/21-801(c)(1) derived from the provision of cable or video service to households located within the Village. The computation of the service provider fee shall be on a quarterly basis.

Section 2: The service provider fee payment shall be due quarterly and payable within 45 days after the close of the preceding calendar quarter. Each payments hall be accompanied by a brief report prepared by a representative of the Grantee showing the basis for the computation. If mailed, the fee shall be considered paid on the date it is postmarked.

Section 3: For purposes of the calculation of the service provider fee, "gross revenues" shall mean consideration of any kind or nature, including, without limitation, cash, credits, property, and in-kind contributions received by Mediacom Illinois, LLC for the operation of its cable system to provide cable or video service within the Village of Greenup.

Section 4: For purposes of the calculation of the service provider fee, "gross revenues" shall not include those items described in 220 ILCS 5/21-801(c)(2).

Section 5: If any section, paragraph, subdivision, clause, sentence, or provision of this Ordinance shall be adjudged by any court of competent jurisdiction to be invalid, such judgment

shall not affect, impair, invalidate, or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

Section 6: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 7: The Ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form (which publication is hereby authorized as provided by law).
