WHEREAS, the Village of Greenup, IL currently maintains a positive balance for Electric Systems, Alternate Revenue Source Bonds of the Village of Greenup; and

WHEREAS, the amount of \$87,390.00 is not necessary for the payment of bond expenses.

The amount of taxes to be extended for 2025 payable in 2026 shall be reduced by the abatement of \$87,390.00.
