**AN ORDINANCE AMENDING ORDINANCE NO. 733
WITH RESPECT TO WATER AND SEWER CHARGES**

WHEREAS, the Village of Greenup adopted Ordinance No. 733 on October 7, 2024, amending Chapters 13.18 and 13.20 of the Village Code with respect to water and sewer charges; and

WHEREAS, Ordinance No. 733 established phased water rate increases for Class A and Class B customers under Section 13.20.90 of the Village Code; and

WHEREAS, the Mayor and Board of Trustees have determined that the Phase 3 water rate increases should be removed and that the remaining provisions of Ordinance No. 733 should continue in full force and effect.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Greenup, Cumberland County, Illinois, as follows:

SECTION ONE: Section Three of Ordinance No. 733, amending Section 13.20.90(A)(a) of the Village Code concerning Class A Base Rates, is hereby amended to read as follows:

a) Base Rates. The following rates are established as the Base Rate applied to all users of the water distribution system whose water consumption does not exceed 1,000 gallons per month. All users of the water system will be increased in a two (2) phase rate increase and annual adjustment per connection, as follows:

1. Phase 1. Effective November 1, 2024, usage billing, the minimum charge of \$34.50 per month for users inside Village Limits.

2. Phase 2. Effective February 1, 2025, usage billing, the minimum charge of \$44.50 per month.

3. Annual Adjustment. This amount shall increase by \$2.00 annually on August 1, 2027, usage billing.

SECTION TWO: Section Three of Ordinance No. 733, amending Section 13.20.90(B)(a) of the Village Code concerning Class B Base Rates, is hereby amended to read as follows:

a) Base Rates. The following rates are established as the Base Rate applied to all users of the water distribution system whose water consumption does not exceed 1,000 gallons per month. All users of the water system will be increased in a two (2) phase rate increase and annual adjustment per connection, as follows:

1. Phase 1. Effective November 1, 2024, usage billing, the minimum charge of \$39.50 per month for users inside Village Limits.

2. Phase 2. Effective February 1, 2025, usage billing, the minimum charge of \$49.50 per month.

3. Annual Adjustment. This amount shall increase by \$2.00 annually on August 1, 2027, usage billing.

SECTION THREE: All provisions of Ordinance No. 733 and Chapters 13.18 and 13.20 of the Village Code not expressly amended by this Ordinance shall remain in full force and effect.

SECTION FOUR: All ordinances, resolutions, or parts thereof in conflict with this Ordinance are hereby repealed to the extent of such conflict.

SECTION FIVE: If any provision of this Ordinance is held invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the remaining provisions of this Ordinance.

SECTION SIX: The Village Clerk is hereby directed to publish this Ordinance in pamphlet form.

SECTION SEVEN: This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
